Trinidad and Tobago COVID-19 (Novel Coronavirus) Update # 408

Port-of-Spain, August 20th 2020: As part of the national drive to safeguard the health of the Trinidad and Tobago population in the face of the global COVID-19 outbreak, the Ministry of Health continues to provide up-to-date information on the country's status in this regard.

The Ministry of Health provides the following clinical update as of the **morning of Thursday 20th August, 2020:**

Number of samples submitted to the Caribbean Public Health Agency (CARPHA), the UWI and other local sites testing for COVID-19.	17,761
Number of unique patient tests completed	15,485

Number of samples which have tested positive at public and private facilities in Trinidad and Tobago	730
Total number of active cases	578

Intensive Care Units (ICUs) are hospital wards that provide treatment for people who are very ill. They are staffed with health care professionals who are trained in ICU treatment and the use of sophisticated monitoring equipment.

High Dependency Units (HDUs) are wards for people who need more observation, treatment and nursing care than is possible in a general ward but slightly less than that given in an Intensive Care Unit.

An Ambulatory Patient is able to walk about and is not bedridden.
