#### Trinidad and Tobago COVID-19 (Novel Coronavirus) Update # 412

**Port-of-Spain, August 22<sup>nd</sup> 2020:** As part of the national drive to safeguard the health of the Trinidad and Tobago population in the face of the global COVID-19 outbreak, the Ministry of Health continues to provide up-to-date information on the country's status in this regard.

**The Ministry of Health reminds the population to source your information only from official sources, such as the Ministry of Health or Ministry of Communications.**

The Ministry of Health provides the following clinical update as of the **morning of Saturday 22<sup>nd</sup> August, 2020:**

<b>Number of samples submitted to the Caribbean Public Health Agency (CARPHA), the UWI and other local sites for testing for COVID-19.</b>	<b>18,735</b>
<b>Number of unique patient tests completed</b>	<b>16,459</b>
<b>Number of repeated tests</b>	<b>2,276</b>
<b>Number of samples which have tested positive at public and private facilities in Trinidad and Tobago</b>	<b>899</b>
<b>Total number of active cases</b>	<b>721</b>
<b>Number of deaths</b>	<b>13</b>
<b>Number of persons discharged</b>	<b>165</b>

The thirty- five (35) positive cases reported below show results from samples taken during the period August 16<sup>th</sup> to August 21<sup>st</sup>, 2020. Therefore, this figure is NOT representative of the positive cases over the last 24 hours only.

The Ministry of Health provides the following update:

The Ministry of Health regrets to inform the public that there is an additional COVID-19 related death. The person is an adult male. This brings the total number of COVID-19 related deaths to 13

- Thirty-five (35) additional persons have tested positive for COVID -19.
- Three (3) persons have been discharged from the Caura Hospital

All established protocols have been implemented.

### **COVID-19 Positive Patients in Hospital – (143)**

**Two hundred and two (202) patients are en route/ being admitted to hospital. Ninety-three (93) new patients will be processed for admission.**

Intensive Care Units (ICUs) are hospital wards that provide treatment for people who are very ill. They are staffed with health care professionals who are trained in ICU treatment and the use of sophisticated monitoring equipment.

High Dependency Units (HDUs) are wards for people who need more observation, treatment and nursing care than is possible in a general ward but slightly less than that given in an Intensive Care Unit.

An Ambulatory Patient is able to walk about and is not bedridden.
