Trinidad and Tobago COVID-19 (Novel Coronavirus) Update # 438

Port-of-Spain, September 4th 2020: As part of the national drive to safeguard the health of the Trinidad and Tobago population in the face of the global COVID-19 outbreak, the Ministry of Health continues to provide up-to-date information on the country's status in this regard.

The population is reminded to source your information only from official sources, such as the Ministry of Health.

The Ministry of Health provides the following clinical update as of the **morning of Friday 4th September, 2020:**

Number of samples submitted to the Caribbean Public Health Agency (CARPHA), the UWI and other local sites for testing for COVID-19.	24,449
Number of unique patient tests completed	21,527
Number of repeated tests	2,922
Number of samples which have tested positive at public and private facilities in Trinidad and Tobago	2,030
Total number of active cases	1293
Number of deaths	30
Number of persons discharged	707

The forty-six (46) positive cases reported below show results from samples taken during the period August 28th to September 2nd, 2020. Therefore, this figure is NOT representative of the positive cases over the last 24 hours only.

The Ministry of Health regrets to inform the public that there is an additional COVID-19 related death. The person is an adult male. This brings the total number of COVID-19 related deaths to 30.

The Ministry of Health provides the following update:

- Forty-six (46) additional persons have tested positive for COVID-19.
All established protocols have been implemented.
- Seven (7) additional persons have been discharged.

COVID-19 Positive Patients in Hospital – (100)

One thousand one hundred and forty-two (1,142) patients are in home isolation under the continuous monitoring of the respective County Medical officer of Health (CMOH) offices.

Forty-six (46) new patients will be processed for admission at the discretion of the CMOHs.

Intensive Care Units (ICUs) are hospital wards that provide treatment for people who are very ill. They are staffed with health care professionals who are trained in ICU treatment and the use of sophisticated monitoring equipment.

High Dependency Units (HDUs) are wards for people who need more observation, treatment and nursing care than is possible in a general ward but slightly less than that given in an Intensive Care Unit.



An Ambulatory Patient is able to walk about and is not bedridden.
